Northamptonshire ACRE (NACRE) is an independent charitable organisation that supports and assist rural communities across the county on a wide range of topics, from developing a community shop, pub or transport scheme, assistance with community and neighbourhood plans, flood risk management, to wanting to know more about the best energy efficiency measures for your hall or how to obtain affordable housing. We are passionate about helping your rural community achieve a vibrant, sustainable future that includes everyone.

Established for over 60 years, NACRE is dedicated to rural matters and we are in a unique position to provide bespoke support specifically tailored to meet the needs of our members such as Parish Councils and their residents. Our Community Facilities Advisor has been supporting village hall and community centre members for over 5 years, offering detailed knowledge and expertise especially around the governance and legislation issues that so many hall committees have to deal with.

We were designated as a Rural Community Council by the government many years ago and are one of 38 RCCs (one in each county) across England. Together, with our national body, ACRE, we form the ACRE Network. The Barns at Hunsbury Hill

We at Northamptonshire ACRE know we are lucky to be able to work in such a lovely environment as the Hunsbury Hill Centre and it seems many other people feel it is a lovely place to get married. We have a trading arm, **The Barns at Hunsbury Hill**, which runs events at the centre such as weddings, corporate and social meetings and wakes.

Our Events Co-Ordinator, Sarah Clarke, did a great job last year in encouraging couples to book at our venue and we had over 80 weddings held at The Barns in 2019. This enabled us to bring any surplus funding generated from the trading arm back into the charity and this is used to support our work with our members across the county.

Sadly this year due to the coronavirus, many of our weddings have had to be postponed to next year, which is upsetting for the couples who have often been planning their big day for many months. However it has given us time to get those little jobs done around the site that keep getting put off to a 'rainy day', so that everything will look wonderful when the weddings can restart.

We also cater for meetings, training events and workshops in our Low Barn or for those larger corporate events why not try our High Barn. There is free parking and wifi, access and facilities for those with mobility impairment and we can provide all refreshments and food from sandwiches to sit down meals to a hog roast.

The view from Northamptonshire ACRE



Meet our new trustee - Miranda Wixon



"I am delighted to join the board of Trustees at Northamptonshire ACRE. Born on Dartmoor now living in rural Northamptonshire for the past 25 years I have a passion for the rights of people in rural life. Qualifying as a Nurse in London I went on to have a career in Senior Management and have always held voluntary sector positions alongside my full time job. I remain committed to speaking up on behalf of others to ensure equality of access to health and social care and for the rights and wellbeing of older and vulnerable people. In the past two years I have been volunteering for food charities and have been drawn by the largely unspoken food poverty that is prevalent in our society and is hidden especially in rural communities.

The current Coronavirus pandemic has changed the way that everyone thinks about food. From the empty supermarket shelves to school closures. 100% of our calorie intake was now taken at home. This only to deepen the marked inequalities that existed before the pandemic hit our shores. Working with SOFEA (South Oxfordshire Food and Education Alliance) and FareShare, the national leader in distribution of surplus food, I was supported to start an emergency larder project in Northamptonshire. With the support of NACRE, SNVB, Grand Union Housing Group and other charities I was able to identify people in all of the villages in South Northants that would help me to distribute food boxes to people isolating and in need. With no charge to individuals and no funding from the councils from 1 April to middle of June 2020 we were able :-

- to deliver 10,000 food boxes;
- * 80 tonnes of food;
- Making 20,000 meals;
- Delivered into 90 towns and villages in South Northants and its surrounds to over 1850 individual homes representing 5000 people;

Working with 500 volunteers

It has been the most incredible mobilisation of volunteers in a generation. Total strangers coming together to help their neighbours in every village and every community within Northamptonshire. It has been a wonderful story to share with so many other volunteers and I am looking forward to working with NACRE to capture the essence that has helped Northamptonshire fight the Coronavirus so far for so many and to look to a post COVID world that has the rural communities at it's heart"

Northamptonshire's COVID-19 Community Champions

Sadly due to the coronavirus outbreak we have had to take the difficult decision to postpone the 2020 Northamptonshire Village Awards.

Normally throughout May and June our dedicated team of volunteer judges would be meeting to shortlist entries, travelling out across Northamptonshire to view the villages that have entered and meet their residents, then deciding on the gold, silver and bronze categories. This year it is not possible to hold our regular Northamptonshire Village Awards due to the measures we must all take to shield vulnerable members of our communities.



But the judges felt they wanted to show recognition of all the work that so many volunteers have been doing across the county to support those in need. Therefore we have decided to launch **Northamptonshire's COVID-19 Community Champions.** Groups across the county are invited to share details of the many ways they are

supporting the more vulnerable in their community. Examples of the support provided can be in whatever way a group chooses, whether through stories, photos, video diaries or brief statements and examples of the best community initiatives will be brought together into a booklet celebrating Northamptonshire's volunteer champions. All entrants will receive a Community Champions certificate and will be invited to take part in a celebratory evening that Northamptonshire ACRE will host in Spring 2021.

Bringing the Rural to the Town: Project update



In the previous Village Viewpoint we told you about the exciting and ambitious project the charity has started with the Hunsbury Hill Centre 'Bringing the rural to the town'. This project centres around the restoration and development of the Grade II listed farmhouse, outbuildings, hovels and the 13 acres of woodland, scrub and gardens.

The overall aim of the project is to enhance the Hunsbury Hill Centre to make it a secure base for NACRE, a valuable resource for the local community, a beacon for the rural communities that NACRE serves and an improved venue for the wedding and conference business. We are also determined that all the improvements will embrace green technology, environmental sustainability and recycling.

We are pleased to announce that we have appointed GSS Architecture, Kettering to work with us in **EGSS**architecture developing the site. GSS Architecture have recently

worked on the renovation of Northampton Museum and have specialist experience of architecture for the conservation of historic buildings.

Northants ACRE is working with GSS to determine how best to develop the site so that it not only makes the most of all the buildings, continues to provide an excellent resource for events but also becomes a valuable community asset and rural beacon for our members, showcasing what can be done that groups can

The first phase of work is to enter an Expression of Interest to the National Lottery Heritage Fund followed by a development application, once the Heritage Fund reopens its programmes. It is also hoped that we will be able to hold our postponed community festival in early Summer 2021 in order to share our ideas and work with our members and the wider community. A Tribute to Mr Edward George Burman 1927—2020

We at Northamptonshire ACRE are always keen to find out more about the heritage of the Hunsbury Hill Farm as it has a fascinating history. We have opened the site up a number of times for the national Heritage Open Days and a few years ago we had an unexpected visitor to the site on one of these days.



Ted with his mother Angelina who continued to live at the cottage till her death.

Edward George Burman or 'Ted' as he was always called, was born at Hunsbury Hill Farm Cottage on 24/12/1927. His mother Angelina and his father George lived at the Farm with her parents.. Ted grew up with his sister Ada on the Hunsbury Hill Farm and loved the tranquil, rural life. As a boy, he helped with the harvest, hay making, ploughing with horses and milking the dairy herd by hand. He grew up with Dick, Jack and Bill Rose whose family worked the farm. Dick still lives in a cottage on the site to this day!

Ted attended Rothersthorpe Elementary School until he was 14 years old and then left to become an apprentice at Matthew's Iron Works as a

wheelwright making wheels for carts. He loved this work and he became very skilled at his job. Ted seemed to be very good at making things with his hands throughout his life whether that was working as a body builder at Aston Martin, where he made the ash frames for those wonderful hand built cars, building a tandem with his best friend Harry, which they used to tour all over Britain, making his own fireworks or designing and creating his own boat! Not everything he built was completely successful - the ski bike he made for his children looked fantastic but unfortunately, the braking and steering system had not been tested. It went like a rocket but there was no alternative but to bail out or crash!

Besides his many building projects, Ted was a proficient skater, loved to dance, developed a successful tennis club and continued to enjoy the rural life he had grown up with , especially shooting and fishing. He met his wife Pat when she was working at the Northampton Library and they were married at St Michael's Church, Kettering 1955. They had two children, Jane and Jeremy. Later in his working life, Ted joined Bells in Kingsthorpe. Pat had become a draughts woman and Ted started to fit the beautifully made marble fire places (that Pat had drawn to scale and hand coloured) into customer's homes. One of those fireplaces is still in Mrs Burman's cottage!

Sadly age finally caught up with Ted and Pat, who became ill with cancer and dementia. Ted looked after her at home right until the end of her life and with the help of his children, continued to live at home afterwards. Ted was quite content with his own company. Having been lucky enough to have had such an interesting and varied life, he loved to tell everyone about the past.



Lockdown was an upsetting time for Ted especially as it meant he could not see his grandchildren, his great granddaughter or meet his new little great grandson. He had suffered with COPD for many years and had developed a chest infection, which made him breathless. Sadly, on the date of his Mother's birthday 16th May 2020 Ted passed away peacefully at home.

We are glad that Ted got to see his old home one more time before he died and the staff and Trustees at Northamptonshire ACRE send their condolences to the Burman family.

Our NLCF Good Neighbour Schemes project



Thank you to the National Lottery Community Fund, which has awarded us over £272,000 to set up Good Neighbour schemes in Northamptonshire

In our last edition we announced that we had been awarded over £272,000 from the National Lottery Community Fund to establish further Good Neighbour schemes in Northamptonshire. The new funding means we can assist up to 30 rural communities across Corby, Wellingborough, Kettering and East Northamptonshire to set up Good Neighbour schemes over the next 3 years.



As the song goes... Everybody Needs Good Neighbours!

These initiatives are run by local volunteers to provide day to day support to other residents in their community who have low level needs and may require help or activities on an occasional or regular basis. This could be collecting prescriptions, dog walking, tidying a garden, changing a plug, providing a lift to the shops, visiting/phoning a resident for chats or taking them to a new activity in the village. This project will enable up to 600 local volunteers to directly support more than 1,000 vulnerable community members – mostly isolated, older people and carers. Together, they'll build stronger relationships and help to lessen some of the loneliness that so many rural residents can go through.

Any group that wants to become a scheme will receive assistance from NACRE with surveys to ascertain need, templates of policies, procedures and constitutions, toolkits and guides, links to other schemes, regular network meetings and support to set up activities to bring residents together. Each new scheme can also apply for up to £700 from the project to help them cover the cost of insurance, DBS checks, publicity and a mobile phone in their first year.




Latest community transport directory

After managing the closure of your facility, you have now had to prepare for its re-opening. Arguably, this requires far greater planning than the relatively straight forward process of closing. Thankfully, National ACRE has produced a detailed information sheet (Issue 3 dated 6 July) setting out what you need to do in order to make your facility Covid-19 secure. This third Issue provides practical information to assist hall managers to comply with the Government Guidance for the safe use of multi-purpose community facilities.



New guide to Rural Community Resilience

From floods to pandemics – resilience for rural communities at times of crisis



Action with Communities in Rural England (ACRE) has published a new guide with Communities Prepared (a Groundwork South initiative) to help rural communities become more resilient in the face of emergencies.

Drawing on the experience of local rural charities and existing initiatives, the guide provides practical tips for rural residents to prepare for, and help each other, at times of crisis. It shows how volunteer groups can be set up to develop emergency plans that identify local risks, and maps out the resources and support which can be mobilised should situations arise that threaten the health, wellbeing and livelihoods of people in the local area.

Financial backing for the guide has been primarily provided by The Prince's Countryside Fund, with additional support from The National Lottery Community Fund.

This essential guide will make it possible for everyone in the countryside to recognise the risks to their community, understand what can be done to prepare for them, and be familiar with the emergency actions that can be taken in conjunction with other agencies should the worst happen.

Future Northants – New Unitary Councils

Local government in Northamptonshire is facing it's biggest change!

Government legislation has now been passed to create a new West Northamptonshire unitary authority serving the areas of Daventry District, Northampton and South Northants, and a new North Northamptonshire unitary authority serving Wellingborough, Kettering, Corby and East Northants. These two new councils will start providing services to the residents and businesses of Northamptonshire in April next year.



The existing eight councils are working together on preparations to

create the two new councils. The new unitary councils will be responsible for all public services provided to residents in their areas – currently these are split between the district and borough councils and the county council, which can seem fragmented to residents, as well as being more costly to deliver in some cases.

In March 2020, Leaders and Chief Executives of the 8 Northamptonshire Councils met the County's MPs to discuss the progress made on Local Government Reform. At the meeting it was agreed that significant benefits could be achieved if everyone looked at delivering a single integrated plan for the transformation.



PROSPECTUS FOR CHANGE: An integrated plan for Local Government Reform and Transformation in Northamptonshire sets out the group's thoughts and key priorities for the Local Government Reform programme. The aim is that positive outcomes for residents and businesses should drive everything that is done. The document can be downloaded at: https://

With many council resources countywide focused on dealing with the Covid-19 response, the scope of the Future Northants Programme is currently being reviewed to understand what needs to be done and can be delivered to create the new unitary councils on 1 April 2021. 
COVID-19 and Mutual Aid Groups



Since the start of the COVID-19 pandemic. we have seen an unprecedented number of groups spring up across the county to help provide support to the more vulnerable residents of their community. The response to the crisis has been fantastic by both local people voluntary and the sector. Northamptonshire ACRE has been working with many of these pop-up groups to ensure they have the necessary support and resources to help them with their volunteering.

Jenni Hedges, our Rural Officer, has produced an Emergency Community response pack, which each group has received. Public Health Northants EqIA

Public Health Northamptonshire has published a coronavirus Equality Impact Assessment that was developed for Northamptonshire Ethics Advisory Group. The assessment explores the impact of the pandemic on different groups of people over various timescales and what any potential mitigations might be.

The EqIA is a snapshot in time in May 2020, so is not the definitive answer it recognises that further impacts and factors will become apparent over the coming months. However it does provide a population level overview that allows organisations to carry out their own more detailed EqIA action plan by clicking on the 'Action' button on each page. PHN is keen to have your feedback about the document and especially whether your organisation has used the action plan.

Spotlight on...

Byfield Good Ministry Neighbours



Whilst Coronavirus presents a significant long-term threat to the health of our rural communities, we are keen to shine a light on the ways rural residents are coming together and helping each other at this time. Over the last few years Northamptonshire ACRE has supported the development of Good Neighbours Schemes across the county and one such is Byfield Good Neighbours. <u>www.byfieldgoodneighbours.com</u>

Rachel Johnston, Secretary for Byfield Good Neighbours Scheme outlined some of the ways they have supported their neighbours during the pandemic. 'Our initial aim was to reduce trips and contact for all Byfielders, so we focussed first on streamlining shopping and it's distribution and the village's prescriptions, with a rota for deliverers that tracked who went to whose property and spread out their volunteering efforts with plenty of time in between requests.' A WhatsApp group was established and Karen the 'Shopping General' organised a team of deliverers to distribute shopping requests safely around the village. Karen even arranged group sourcing efforts from a fruit & veg wholesaler who delivered twice weekly orders, and large bags of flour and potatoes that could be shared by all those who needed it.

Although Byfield had a good bank of volunteers going in to the crisis, a significant number of them needed to shield, so the group were always considering how they could be included in the Good Neighbours activity for the village. For some, this was making friendly care calls to those feeling lonely, or sourcing items from their sheds or kitchen cupboards when a request was put out. Other initiatives were the Plant and Seed Exchange, which was a roaring success, regular delivery of papers to a core set of villagers, a website with weekly quizzes posted, village virtual scavenger hunts, sharing photos of favourite spots, resources for home-schooling, and 93 year old Dorothy happy to coach villagers on what

Heritage Emergency Fund – The National Lottery Heritage Fund

The National Lottery Heritage Fund has put together a £50million fund to support the heritage sector as an immediate response to the coronavirus (COVID-19) outbreak. The UK-wide fund - money raised from The National Lottery - will address immediate pressures over the next few months for those organisations most in need. It is now open for applications until 30 June.

The £50m fund is available for grants of between £3,000 and £50,000. It is available to organisations across the full breadth of heritage, including historic sites, industrial and maritime heritage, museums, libraries and archives, parks and gardens, landscapes and nature. Organisations which have received funding in the past or are either a current grantee, or still under contract following a previous grant, can apply.

Priority will be given where:

- there is limited or no access to other sources of support
- where heritage is most at risk
- where an organisation is at risk of severe financial crisis due to coronavirus (COVID-19)

Church Conservation Grants – William and Jane Morris Fund

The Morris Fund was formed in 1939, using a bequest to the Society from May Morris, younger daughter of William and Jane Morris. In accordance with May's will, the Fund only supports work carried out under the principles of the Society for the Protection of Ancient Buildings (SPAB), which was founded by May's father .

Grants between £500 and £5,000 are awarded to churches, chapels and other places of worship in the United Kingdom for the conservation of decorative features and monuments, but not for structural repairs. Grants will be awarded to support smaller programmes of work concerned with the conservation of decorative or non-structural features such as:

- stained glass windows
- sculpture
- furniture
- internal monuments and tombs
- wall paintings

Grant schemes for electric vehicle charging infrastructure

The government offers grants to support the wider use of electric and hybrid vehicles via the Office of Low Emission Vehicles (OLEV). This includes:

Community energy grants and support

Rural Community Energy Fund

The Rural Community Energy Fund (RCEF) is a £10 million programme that supports rural communities in England to develop renewable energy projects with community benefit. It is being delivered by the five Energy Hubs in the North East, North West, Midlands, South West and South East of England on behalf of the Department for Business, Energy & Industrial Strategy and the Department for Environment, Food & Rural Affairs.

The aims of the fund are to:

- * Support rural communities by helping them to maximise the income-generating potential of renewable energy and put this income to work in their local area
- Increase the uptake of community and locally-owned renewable energy to support the Government's targets for renewable energy and carbon reduction
- * Enable communities to access the economic and social benefits associated with renewable energy schemes through the promotion of rural growth, job creation and volunteering opportunities.

Rural communities can apply for up to £140,000 in funding to support renewable energy projects. RCEF offers grants to help cover the costs of professional fees and consultancy when investigating whether a project is viable, and for creating a full business case to take projects forward. Examples of the types of technologies that can be used in renewable energy projects include solar panels, wind turbines, hydropower and heat pumps. Green Homes Grant



From September 2020 homeowners are able to apply for a £5,000 Green Homes Grant voucher to pay for the installation of energy saving home improvements.

This is part of a new government grant scheme comprising a ± 3 billion investment to help the UK meet climate change goals. The scheme will officially launch in September with applications for required energy

efficiency measures distributed to local accredited installers.

Once one of these suppliers has provided a quote and the work is approved, the voucher is issued. Approximately half of the fund will be distributed to the poorest homeowners, who will not have to contribute anything to the cost. Improved energy solutions like cavity and loft insulation can save households up to £600 a year on energy bills and significantly reduce carbon emissions. https://www.government-grants.co.uk/green-homes-grant-voucher

Be #ScamAware

It's important to always keep an eye out for scams. They can and do affect anyone. People can be especially vulnerable at times like this when they're worried about their families, health, money and work. If you think you have been scammed, there are 3 steps you need to take:

Could it be a scam?

Be #ScamAware Contact the Citizens Advice consumer service online or at

0808 223 1133 for advice.

Watch out for coronavirus scams whether that's emails pretending to be from the government, adverts selling face masks at high prices, or someone knocking at your door asking for money for a fake charity.

Don't give money or personal details to anyone you don't know or trust, and don't click on any links they send you.



1) **Contact your b**ank immediately to let them know what's happened. You should also change any relevant log-in details, and check for viruses if you were scammed on a computer.

2) If you have lost money because of a scam, **check if you can get it back.** Make sure you tell your bank what happened straight away. If you've paid for something by card or PayPal, depending on the circumstances they might be able to help you get your money back.

3) **Report the scam**. This helps the enforcement authorities to track down and stop the criminals responsible, and protects others from being scammed:

• Call the **Citizens Advice consumer service** on 0808 223 1133. We'll pass on details of the scam to Trading Standards, and be able to provide further advice

• Report all types of scams to **Action Fraud**, the UK's national reporting centre for fraud. They'll also give you a crime reference number.

Here are some of the main warning signs of scams to look out for:

- * It seems too good to be true for example you've won a competition you don't remember entering
- * Someone you don't know contacts you unexpectedly
- You're being urged to respond quickly so you don't get time to think about it or talk to family and friends
- * You've been asked to pay in an unusual way for example by bank transfer or gift vouchers
- * You've been asked to give away personal information

If you think someone might be trying to scam you, get advice. Contact the Citizens Advice consumer service for help with what to do next, and report scams or suspected scams to Action Fraud.

Charity Commission Updates



COVID-19 Guidance for the charity sector
